**NOTICE TO EXHIBITORS REGARDING CORRECTION OR CHANGES TO ENTRIES:** The specific changes listed in Ch. 11, Sec. 6 (i.e. sex of a dog, transfers between age specific regular classes and "move-ups" to BOV or BOB) of the Dog Show Rules are the **only** changes to the entries superintendents or secretaries are authorized to make **after closing of entries. THIS RULE IS STRICTLY ENFORCED BY THE AMERICAN KENNEL CLUB. PLEASE CHECK YOUR ENTRIES CAREFULLY.** Corrections to entries may be made by the Superintendent prior to the closing of entries if such correction is submitted in writing. Exhibitors are required to report any changes/corrections after closing directly to the American Kennel Club.

#### Bred-by Exhibitor (BBE) Class eligibility

The Bred-by-Exhibitor Class shall be for dogs that are: a) Six months of age or older as of the first day of the show; b) Not Champions of record on the date of closing of entries for the show; c) Individually registered with the American Kennel Club as of the date of closing of entries for the show; d) Owned or co-owned by any of the breeders of record as of the date of the closing of entries for the show. The person handling the dog in this class must be a breeder of record and an owner of record of this dog. In any subsequent classes for which the dog from the Bred-by-Exhibitor class becomes eligible, there are no restrictions as to who may handle.

NOTE: Winners from these classes are eligible, if undefeated in another class for Best of Breed Competition.

Veteran Dog Class, 7 years and under 9 years      Veteran Bitch Class, 7 years and under 9 years

\* Chapter 11, Section 8: of the "Rules Applying to Dog Shows" provides that a neutered male may be entered as a Veteran Dog in the Veteran Dog Class and a spayed bitch may be entered as a Veteran Bitch in the Veteran Bitch Class:

### NON-REGULAR CLASSES INVOLVING MULTIPLE DOG ENTRIES

NOTE: As the judges' decision in the Non-Regular Classes involving Multiple Dog Entries is based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible to compete for Best of Breed by virtue of having won these classes.

**\*Stud Dog Class** - For Stud Dogs and two of their Get. Owner of the Stud Dog need not be owner of the Get. Stud Dogs may be entered separately in one of the Regular or Non-Regular Classes, or if a Champion of Record, for Best of Breed, or may be entered for Stud Dog Class only at the regular entry fee. The Get *MUST* be entered in one of the Regular Classes. The Stud Dog must be entered in the Stud Dog Class and must be shown in the ring with his get. Get only to be judged, based on the merits of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy or the Standard for the Breed.

**\*Brood Bitch Class** - Same as Stud Dog Class, except substitute Brood Bitch for Stud Dog and Produce for Get.

\*Chapter 11, Section 8: of the "Rules Applying to Dog Shows" provides that "a castrated male may be entered as a Stud Dog in the Stud Dog Class and a spayed bitch may be entered as a Brood Bitch in the Brood Bitch Class".

**MAIL ALL ENTRIES WITH ENTRY FEES TO GARVIN SHOW SERVICES**, 14622 SE Old Barn Lane, Damascus, OR 97089-9267. Acknowledgment of entries will be made as soon as possible after entries have closed. Confirmation of entry and Judging Program will be sent via First Class USPS mail to the address listed on the Official AKC Entry Form per AKC Rules and Regulations. **E-MAIL CONFIRMATION NOTICES WILL NOT BE SENT.**

**IF YOU NEED INFORMATION** regarding your entry phone (503) 558-1221. To ensure entries remain confidential until the opening of the event, please use the entry verification space on the entry form by filing in any four numbers of your choice which we can use to verify phone inquiries are being requested by the dog's owner or agent.

**AN AKC RECORDING FEE** of \$.50 and an AKC Event Service Fee of \$3.00 will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test. If a dog is entered in more than one class in one of these events, the AKC Recording Fee is to be collected on the first entry only and the AKC Event Service fee is to be collected on each of the entries of that dog. All Recording and Event Service Fees are paid to the American Kennel Club. (AKC Rules Applying to Dog Shows, Chapter 11, Section 2). (There is no Recording Fee or Event Service Fee for Junior Showmanship, Sweepstakes, Futurities, Brace/Team, Multi-Dog Classes or Special Attractions.)

**MAKE ALL CHECKS OR MONEY ORDERS** payable in U.S. Funds to Garvin Show Services. The Superintendent assumes no responsibility for cash sent through the mail.

**RETURNED CHECKS AND INVALID/DECLINED CREDIT CARDS** do not constitute a valid entry fee. Returned checks and invalid/declined credit cards **MUST BE MADE GOOD BEFORE** the dog(s) will be allowed in the ring. Any person that issues a check that is returned for non-payment, or submits payment by credit card that is declined, will be required to pay a fine of \$25 in addition to the entry fees for which check or checks were issued or for charges to the declined credit card. The entry fee plus the \$25 shall then be paid by cash, money order, or cashier's check. Subsequent returned checks or declined credit cards from the same exhibitor may result in their being put on a **CASH ONLY** basis.

**CONDITIONAL, UNSIGNED, INCOMPLETE**, or entries received without fees will not be accepted.

**OWNERS ARE RESPONSIBLE** for errors on entry blanks including wrong information, entering a dog in a class in which the dog is not eligible to compete or for entering the same dog twice. No refunds for duplicate entries.

**ENTRIES NOT ON OFFICIAL AKC FORMS** or downloaded or photocopies of entry forms without rules and agreement on reverse side of Official AKC entry form and/or not within the official AKC entry size are **NOT** acceptable.

**CHANGES, ADDITIONS OR CORRECTIONS** to entry forms must be received in writing, by email, or by telegram **prior to the close of entries**. Those received by telephone are not acceptable.

**FACSIMILE MACHINE ENTRIES** for this event will be accepted with payment by credit card up to closing time. You must include the front and back of the entry form. **ALL PAYMENTS BY CREDIT CARD** will be treated as FAX entries and are subject to fax service fees.

**ENTRY FEES SHALL NOT BE REFUNDED** in the event that a dog is absent, disqualified, sick, lame, excused by Judge, or barred from competition by action of the Event Committee, or because the dog is ineligible to compete due to being entered incorrectly. There is no refund of entry fee for duplicate entry or overpayment of entry fees. If because of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other acts beyond the control of the Club or Superintendent, it is impossible to open or complete an event, no refund of entry fees will be made. Extreme weather conditions, such as but not limited to, snow storms, hurricanes, lightning, extreme heat, or the condition of the facilities or grounds and/or the ingress and egress from the grounds, must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and in the event it is necessary to cancel or stop the event before completion, no refund of entry fee will be made. **To find out about any AKC event cancellations call the AKC Event Cancellation Hotline - 877-252-3229**

**AN ADMINISTRATIVE FEE** of \$4.00 per dog per show will be charged for all cancellations or changes made prior to closing of entries. Because of the cost of processing no refunds of less than \$10.00 will be issued.

**AFTER CLOSING, NO DOGS** wrongly entered in a class may be transferred to another class, unless specifically allowed for in AKC Rules & Regulations.

**AS SPECIFIED IN CHAPTER 12, SECTION 4** of the AKC Rules Applying to Dog Shows, information contained on the entry form is required to be published in the Club's show catalog. This information is also subject to publication in other media.

**THE EVERGREEN SHIBA INU CLUB** reserves the right to substitute a prize of equal or greater value.

**ALL TROPHIES** must be claimed the day of the show. None will be mailed or otherwise distributed.

**CLASS CASH PRIZES** will be paid in the ring to the person showing the dog. Claims for prize money must be made in the ring before the judging is over and the Superintendent's Office advised at once. The Superintendent and the Club disclaim any liability for cash prizes after the judging of the class is over.

**ALL DOGS** must be held on leash or confined to their crates except when being judged or when in the exercising pen.

**THERE SHALL BE NO** drilling nor intensive or corrective training of dogs on the show grounds or premises.

**NO FLEXI LEADS, HALTI TYPE COLLARS OR PINCH COLLARS ON THE GROUNDS.**

**NO PRACTICING IN RINGS. DOGS ALLOWED** in rings during judging only.

**DOGS MUST BE READY FOR JUDGING.** The Club and the Superintendent will not be responsible and are not obligated to furnish any service for notifying exhibitors or their agents of breed or class judging. Judges will not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging ring.

**DOGS NEED TO BE AT THE SHOW** only at scheduled time of judging and may leave immediately thereafter, unless required for further judging.

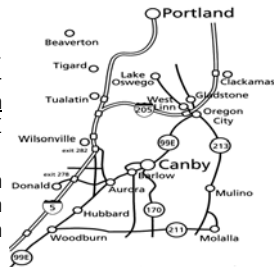
#### OVERNIGHT PARKING
