**Bred-by Exhibitor (BBE) Class eligibility**

The Bred-by-Exhibitor Class shall be for dogs that are: a) Six months of age or older as of the first day of the show; b) Not Champions of record on the date of closing of entries for the show; c) Individually registered with the American Kennel Club as of the date of closing of entries for the show; d) Owned or co-owned by any of the breeders of record as of the date of the closing of entries for the show. **The person handling the dog in this class must be a breeder of record and an owner of record of this dog.** In any subsequent classes for which the dog from the Bred-by-Exhibitor class becomes eligible, there are no restrictions as to who may handle.

**BEST OF BREED COMPETITION**

The following categories of dogs may be entered and shown in Best of Breed Competition. Dogs that are Champions of Record. Dogs which according to their owner's records have completed the requirements for a championship but whose championships are unconfirmed. The entry and showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a championship according to the owner's records. If, at the end of the 90 day period, the championship of a dog has not been confirmed by the American Kennel Club, no further entries of the dog for Best of Breed competition are to be made until its championship has been confirmed by the AKC.

**SPECIAL COMPETITION - To be judged immediately following Best of Breed Competition**

**NON-REGULAR CLASSES INVOLVING SINGLE DOG ENTRIES - BOTH EVENTS**

*NOTE: Winners from these classes are eligible, if undefeated in another class, for Best of Breed Competition.*

**NON-REGULAR CLASSES INVOLVING MULTIPLE DOG ENTRIES**

*NOTE: As the judges' decision in the Non-Regular Classes involving Multiple Dog Entries is based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in these classes will be eligible to compete for Best of Breed (Variety) by virtue of having won these classes.*

\*Stud Dog Class      \*Brood Bitch Class

For DOG or BITCH shown with two of their Get/Produce. Stud Dogs/Brood Bitches must be entered in the Stud Dog/Brood Bitch Class and must be shown in the ring with their Get/Produce. The owner of the Stud Dog/Brood Bitch need not necessarily be owner of the Get/Produce. While the merits of the Stud Dog/Brood Bitch are not to be considered in the placement of the entry, the Stud Dog/Brood Bitch must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC Policy, or the standard for its breed. Get/Produce must be entered and shown in a Regular Class, Best of Breed (Variety) Competition, or some other Non-Regular Class.

*\*Chapter 11, Section 8 of the "Rules Applying to Dog Shows" provides that a castrated male may be entered as a Stud Dog in the Stud Dog Class and a spayed bitch may be entered as a Brood Bitch in the Brood Bitch Class.\**

**ENTRIES CLOSE WEDNESDAY, JULY 2, 2008 AT 6:00 PM, PACIFIC TIME**, at the Superintendent's office after which time entries cannot be accepted, canceled, altered or substituted except as provided for in Chapter 11, Section 6 of the Dog Show Rules or in the Obedience Regulations.

**MAIL ALL ENTRIES WITH ENTRY FEES TO GARVIN SHOW SERVICES**, 14622 SE Old Barn Lane, Damascus, OR 97089-9267. Acknowledgment of entries will be made as soon as possible after entries have closed. Confirmation of entry and Judging Program will be sent via First Class USPS mail to the address listed on the Official AKC Entry Form per AKC Rules and Regulations. **E-MAIL CONFIRMATION NOTICES WILL NOT BE SENT.**

**IF YOU NEED INFORMATION** regarding your entry phone (503) 558-1221. To ensure entries remain confidential until the opening of the events, please use the entry verification space on the entry form by filing in any four numbers of your choice which we can use to verify phone inquiries are being requested by the dog's owner or agent.

**AN AKC RECORDING FEE** of \$.50 and an AKC Event Service Fee of \$3.00 will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test. If a dog is entered in more than one class in one of these events, the AKC Recording Fee is to be collected on the first entry only and the AKC Event Service fee is to be collected on each of the entries of that dog. All Recording and Event Service Fees are paid to the American Kennel Club. (AKC Rules Applying to Dog Shows, Chapter 11, Section 2). (There is no Recording Fee or Event Service Fee for Junior Showmanship, Sweepstakes, Futurities, Brace/Team, Multi-Dog Classes or Special Attractions.) All fees are paid to the American Kennel Club.

**MAKE ALL CHECKS OR MONEY ORDERS** payable in U.S. Funds to Garvin Show Services. The Superintendent assumes no responsibility for cash sent through the mail.

**CANADIAN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTERNATIONAL MONEY ORDERS IN U.S. FUNDS.**

**RETURNED CHECKS AND INVALID/DECLINED CREDIT CARDS** do not constitute a valid entry fee. Returned checks and invalid/declined credit cards **MUST BE MADE GOOD BEFORE** the dog(s) will be allowed in the ring. Any person that issues a check that is returned for non-payment, or submits payment by credit card that is declined, will be required to pay a fine of \$25 in addition to the entry fees for which check or checks were issued or for charges to the declined credit card. The entry fee plus the \$25 shall then be paid by cash, money order, or cashier's check. Subsequent returned checks or declined credit cards from the same exhibitor may result in their being put on a **CASH ONLY** basis.

**CONDITIONAL, UNSIGNED, INCOMPLETE**, or entries received without fees will not be accepted.

**OWNERS ARE RESPONSIBLE** for errors on entry blanks including wrong information, entering a dog in a class in which the dog is not eligible to compete or for entering the same dog twice. No refunds for duplicate entries.

**ENTRIES NOT ON OFFICIAL AKC FORMS** or downloaded or photocopies of entry forms without rules and agreement on reverse side of Official AKC entry form and/or not within the official AKC entry size are **NOT** acceptable.

**CHANGES, ADDITIONS OR CORRECTIONS** to entry forms must be received in writing, by email, or by telegram **prior to the close of entries**. Those received by telephone are not acceptable.

**ALL PAYMENTS BY CREDIT CARD** will be treated as FAX entries and are subject to fax service fees.

**ENTRY FEES SHALL NOT BE REFUNDED** in the event that a dog is absent, disqualified, sick, lame, excluded by Judge, or barred from competition by action of the Event Committee, or because the dog is ineligible to compete due to being entered incorrectly. There is no refund of entry fee for duplicate entry or overpayment of entry fees. If because of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other acts beyond the control of the Club or Super

intendent, it is impossible to open or complete an event, no refund of entry fees will be made. Extreme weather conditions, such as but not limited to, snow storms, hurricanes, lightning, extreme heat, or the condition of the facilities or grounds and/or the ingress and egress from the grounds, must be considered for the health and safety of the dogs, exhibitors and spectators.
