Bred-by Exhibitor Class Eligibility

The Bred-by-Exhibitor Class shall be for dogs that are: a) Six months of age or older as of the first day of the show; b) Not Champions of record on the date of closing of entries for the show; c) Individually registered with the American Kennel Club as of the date of closing of entries for the show; d) Owned or co-owned by any of the breeders of record as of the date of the closing of entries for the show. The person handling the dog in this class must be a breeder of record and an owner of record of this dog. In any subsequent classes for which the dog from the Bred-by-Exhibitor class becomes eligible, there are no restrictions as to who may handle.

A Class for Dogs and a Class for Bitches 7 years old or older.

* Chapter 11, Section 8: of the "Rules Applying to Dog Shows" provides that a neutered male may be entered as a Veteran Dog in the Veteran Dog Class and a spayed bitch may be entered as a Veteran Bitch in the Veteran Bitch Class".

NON-REGULAR CLASSES INVOLVING MULTIPLE DOG ENTRIES

NOTE: As the judges' decision in the Non-Regular Classes involving Multiple Dog Entries is based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible to compete for Best of Breed by virtue of having won these classes.

*Stud Dog Class *Brood Bitch Class

For DOG or BITCH shown with at least two and no more than four of their Get/Produce. Stud Dogs/Brood Bitches must be entered in the Stud Dog/Brood Bitch Class and must be shown in the ring with their Get/Produce. The owner of the Stud Dog/Brood Bitch need not necessarily be owner of the Get/Produce. While the merits of the Stud Dog/Brood Bitch are not to be considered in the placement of the entry, the Stud Dog/Brood Bitch must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC Policy, or the standard for its breed. Get/Produce must be entered in a regular class, Best of Breed (Variety) competition, or some other non-regular class.

*Chapter 11, Section 8: of the "Rules Applying to Dog Shows" provides that "a castrated male may be entered as a Stud Dog in the Stud Dog Class and a spayed bitch may be entered as a Brood Bitch in the Brood Bitch Class".

To ensure entries remain confidential until the opening of the event, please use the entry verification space on the entry form by filing in any four numbers of your choice which we can use to verify phone inquiries are being requested by the dog's owner or agent.

GENERAL INFORMATION AND SHOW RULES continued

AN AKC RECORDING FEE of \$.50 and an AKC Event Service Fee of \$3.00 will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test. If a dog is entered in more than one class in one of these events, the AKC Recording Fee is to be collected on the first entry only and the AKC Event Service fee is to be collected on each of the entries of that dog. All Recording and Event Service Fees are paid to the American Kennel Club. (AKC Rules Applying to Dog Shows, Chapter 11, Section 2). (There is no Recording Fee or Event Service Fee for Junior Showmanship, Sweepstakes, Futurities, Brace/Team, Multi-Dog Classes or Special Attractions.)

MAKE ALL CHECKS OR MONEY ORDERS payable in U.S. Funds to Garvin Show Services. The Superintendent assumes no responsibility for cash sent through the mail.

RETURNED CHECKS AND INVALID/DECLINED CREDIT CARDS do not constitute a valid entry fee. Returned checks and invalid/declined credit cards **MUST BE MADE GOOD BEFORE** the dog(s) will be allowed in the ring. Any person that issues a check that is returned for non-payment, or submits payment by credit card that is declined, will be required to pay a fine of \$25 in addition to the entry fees for which check or checks were issued or for charges to the declined credit card. The entry fee plus the \$25 shall then be paid by cash, money order, or cashier's check. NO FLEXI LEADS, HALTI TYPE COLLARS OR PINCH COLLARS ON THE GROUNDS.

NO PRACTICING IN RINGS. DOGS ALLOWED in rings during judging only.

DOGS MUST BE READY FOR JUDGING. The Club and the Superintendent will not be responsible and are not obligated to furnish any service for notifying exhibitors or their agents of breed or class judging. Judges will not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging ring.

DOGS NEED TO BE AT THE SHOW only at scheduled time of judging and may leave immediately thereafter, unless required for further judging.

EXHIBITORS ARE RESPONSIBLE for maintaining clean conditions in and around their crates/set-up.

AKC RULES STATE THAT ONLY DOGS THAT ARE ELIGIBLE to be shown under the American Kennel Club rules shall be allowed within the show precincts.
