Amateur Owner Handler (AOH) Class Eligibility

(Effective as of 1/1/2009) Chapter 3, Section 7 of the AKC *Rules Applying to Dog Shows* "The Amateur-Owner-Handler class shall be for dogs that are at least six months of age that are not champions. Dogs must be handled in the class by the registered owner of the dog. This class is restricted to exhibitors who have not, at any point in time, been a professional dog handler, AKC approved conformation judge, or employed as an assistant to a professional handler. Additionally, members of the immediate family or household of a current professional handler are ineligible for this class (as defined in Chapter 11, Section 13)."

Bred by Exhibitor Dogs Bred by Exhibitor Bitches

Bred-by Exhibitor (BBE) Class eligibility

The Bred-by-Exhibitor Class shall be for dogs that are: a) Six months of age or older as of the first day of the show; b) Not Champions of record on the date of closing of entries for the show; c) Individually registered with the American Kennel Club as of the date of closing of entries for the show; d) Owned or co-owned by any of the breeders of record as of the date of the closing of entries for the show. The person handling the dog in this class must be a breeder of record and an owner of record of this dog. In any subsequent classes for which the dog from the Bred-by-Exhibitor class becomes eligible, there are no restrictions as to who may handle.

Special Competition: Best Puppy from the Regular Classes & Best Bred by Exhibitor

NON-REGULAR CLASSES INVOLVING SINGLE DOG ENTRIES

NOTE: Winners from these classes are eligible, if undefeated in another class, for Best of Breed Competition.

- *Veteran Dog Class *Veteran Bitch Class

A Class for Dogs and a Class for Bitches 7 years old or older.

* Chapter 11, Section 8: of the "Rules Applying to Dog Shows" provides that a neutered male may be entered as a Veteran Dog in the Veteran Dog Class and a spayed bitch may be entered as a Veteran Bitch in the Veteran Bitch Class.

NON-REGULAR CLASSES INVOLVING MULTIPLE DOG ENTRIES

NOTE: As the judges' decision in the Non-Regular Classes involving Multiple Dog Entries is based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible to compete for Best of Breed by virtue of having won these classes.

- *Stud Dog Class *Brood Bitch Class

For DOG or BITCH shown with at least two and no more than four of their Get/Produce. Stud Dogs/Brood Bitches must be entered in the Stud Dog/Brood Bitch Class and must be shown in the ring with their Get/Produce. The owner of the Stud Dog/Brood Bitch need not necessarily be owner of the Get/Produce. While the merits of the Stud Dog/Brood Bitch are not to be considered in the placement of the entry, the Stud Dog/Brood Bitch must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC Policy, or the standard for its breed. Get/Produce must be entered in a regular class, Best of Breed (Variety) competition, or some other non-regular class.

*Chapter 11, Section 8: of the "Rules Applying to Dog Shows" provides that "a castrated male may be entered as a Stud Dog in the Stud Dog Class and a spayed bitch may be entered as a Brood Bitch in the Brood Bitch Class".

Brace Class - For two Shih Tzu with at least one common owner and presented in the ring by no more than two handlers. Both dogs must be entered in another class. The entry fee is \$15.00 for the Brace as a UNIT. The entry form for each dog entered as a part of a brace MUST be marked accordingly in the space for Additional Classes - "Brace Class". If more than one Brace is entered by the same owner, the dogs comprising each Brace must be so designated, "Brace No. 1", "Brace No. 2", etc.

Confirmation of entry and Judging Program will be sent via First Class USPS mail to the address listed on the Official AKC Entry Form per AKC Rules and Regulations. **E-MAIL CONFIRMATION NOTICES WILL NOT BE SENT.**

IF YOU NEED INFORMATION regarding your entry phone (503) 558-1221. RETURNED CHECKS AND INVALID/DECLINED CREDIT CARDS do not constitute a valid entry fee. Returned checks and invalid/declined credit cards **MUST BE MADE GOOD BEFORE** the dog(s) will be allowed in the ring. Any person that issues a check that is returned for non-payment, or submits payment by credit card that is declined, will be required to pay a fine of \$25 in addition to the entry fees for which check or checks were issued or for charges to the declined credit card. The entry fee plus the \$25 shall then be paid by cash, money order, or cashier's check. Subsequent returned checks or declined credit cards from the same exhibitor may result in their being put on a **CASH ONLY** basis.

CONDITIONAL, UNSIGNED, INCOMPLETE, or entries received without fees will not be accepted.

open or complete an event, no refund of entry fees will be made. Extreme weather conditions, such as but not limited to, snow storms, hurricanes, lightning, extreme heat, or the condition of the facilities or grounds and/or the ingress and egress from the grounds, must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and in the event it is necessary to cancel or stop the event before completion, no refund of entry fee will be made. **To find out about any AKC event cancellations call the AKC Event Cancellation Hotline - 877-252-3229.**

AN ADMINISTRATIVE FEE of \$4.00 per dog per show will be charged for all cancellations or changes made prior to closing of entries. Because of the cost of processing no refunds of less than \$10.00 will be issued.

AFTER CLOSING, NO DOGS wrongly entered in a class may be transferred to another class, unless specifically allowed for in AKC Rules & Regulations.

AS SPECIFIED IN CHAPTER 12, SECTION 4 of the AKC Rules Applying to Dog Shows, information contained on the entry form is required to be published in the Club's show catalog. This information is also subject to publication in other media.

NO FLEXI LEADS, HALTI TYPE COLLARS OR PINCH COLLARS ON THE SHOW GROUNDS.

NO PRACTICING IN RINGS. DOGS ALLOWED in rings during judging only.

DOGS MUST BE READY FOR JUDGING. The Club and the Superintendent will not be responsible and are not obligated to furnish any service for notifying exhibitors or their agents of breed or class judging. Judges will not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging ring.

DOGS NEED TO BE AT THE SHOW only at scheduled time of judging and may leave immediately thereafter, unless required for further judging.

EXHIBITORS ARE RESPONSIBLE for maintaining clean conditions in and around their crates/set-up.

AKC RULES STATE THAT ONLY DOGS THAT ARE ELIGIBLE to be shown under the American Kennel Club rules shall be allowed within the show precincts.

EXHIBITORS SHOULD FOLLOW THEIR VETERINARIAN'S RECOMMENDATION to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.
