Bred-by Exhibitor Class Eligibility

The Bred-by-Exhibitor Class shall be for dogs that are: a) Six months of age or older as of the first day of the show; b) Not Champions of record on the date of closing of entries for the show; c) Individually registered with the American Kennel Club as of the date of closing of entries for the show; d) Owned or co-owned by any of the breeders of record as of the date of the closing of entries for the show. The person handling the dog in this class must be a breeder of record and an owner of record of this dog. In any subsequent classes for which the dog from the Bred-by-Exhibitor class becomes eligible, there are no restrictions as to who may handle.

NON-REGULAR CLASSES INVOLVING SINGLE DOG ENTRIES

Because winners of these classes will compete for Best of Breed, all entrants **MUST** also meet ALL American Kennel Club requirements for Non-Regular Classes involving single dog entries. NOTE: Any placement other than First in any of these classes eliminates the dog from competing in Best of Breed Competition.

Working Dog Working Bitch

For dogs or bitches registered with the American Kennel Club. ILP numbers are not accepted. Dogs may not be neutered and bitches may not be spayed. Entrants must have a Samoyed Club of America Working Dog Title, either WS, WSX or WSXM, or any other AKC performance title: i.e., to include but not limited to obedience or any other AKC performance title event.

- *Veteran Dog Class, 7 years and under 10 years
 - *Veteran Dog Class, 10 years and under 12 years
 - *Veteran Dog Class, 12 years and over
 - *Veteran Bitch Class, 7 years and under 10 years

- * Chapter 11, Section 8: of the "Rules Applying to Dog Shows" provides that a neutered male may be entered as a Veteran Dog in the Veteran Dog Class and a spayed bitch may be entered as a Veteran Bitch in the Veteran Bitch Class".

NON-REGULAR CLASSES INVOLVING MULTIPLE DOG ENTRIES

NOTE: As the judges' decision in the Stud Dog, Brood Bitch Classes is based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in these classes will be eligible to compete for Best of Breed by virtue of having won these classes.

****Stud Dog Class** - For Stud Dogs shown with two to four of their Get. The owner of the Stud Dog need not necessarily be owner of the Get. The Get **MUST** be entered and shown in one of the regular classes at this show. The Stud Dog is the only dog to be listed on the entry form and must be shown in the ring with his Get. Awards will be based on the merits of the Get. The Stud Dog and Get shall be considered as one entry for determining entry fees for this class. The Stud Dog may be entered separately in one of the regular or non-regular conformation classes, or in Best of Breed competition if eligible, in which case, Stud Dog shall be considered a second entry of the same dog, requiring an entry fee of \$22.00. If entered only in Stud Dog Class, the fee shall be the regular entry fee of \$26.00.

****Brood Bitch Class** - Same as Stud Dog, except substitute Brood Bitch for Stud Dog and Produce for Get.
 **Chapter 11, Section 8: of the "Rules Applying to Dog Shows" provides that "a castrated male may be entered as a Stud Dog in the Stud Dog Class and a spayed bitch may be entered as a Brood Bitch in the Brood Bitch Class".

JUDGES AWARD OF MERIT

OWNERS ARE RESPONSIBLE for errors on entry blanks including wrong information, entering a dog in a class in which the dog is not eligible to compete or for entering the same dog twice. No refunds for duplicate entries.

ENTRIES NOT ON OFFICIAL AKC FORMS or downloaded or photocopies of entry forms without rules and agreement on reverse side of Official AKC entry form and/or not within the official AKC entry size are **NOT** acceptable.

CHANGES, ADDITIONS OR CORRECTIONS to entry forms must be received in writing, by email, or by telegram *prior to the close of entries*. Those received by telephone are not acceptable.

ALL PAYMENTS BY CREDIT CARD will be treated as FAX entries and are subject to fax service fees.

ENTRY FEES SHALL NOT BE REFUNDED in the event that a dog is absent, disqualified, sick, lame, excused by Judge, or barred from competition by action of the Event Committee, or because the dog is ineligible to compete due to being entered incorrectly. There is no refund of entry fee for duplicate entry or overpayment of entry fees. If because of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other acts beyond the control of the Club or Superintendent, it is impossible to open or complete an event, no refund of entry fees will be made. Extreme weather conditions, such as but not limited to, snow storms, hurricanes, lightning, extreme heat, or the condition of the facilities or grounds and/or the ingress and egress from the grounds, must be considered for the health and safety of the dogs, exhibitors and spectators. REFUNDS for cancellations due to judge change or cancellations made prior to entries closing will be mailed to said Exhibitor or Agent **AFTER THE SHOW**. An administrative fee of \$5.00 will be withheld from all refunds for entries cancelled prior to the closing of entries. Because of the cost of processing, no refunds of less than \$10.00 will be issued.

AFTER CLOSING, NO DOGS wrongly entered in a class may be transferred to another class, unless specifically allowed for in AKC Rules & Regulations.

AS SPECIFIED IN CHAPTER 12, SECTION 4 of the AKC Rules Applying to Dog Shows, information contained on the entry form is required to be published in the Club's show catalog. This information is also subject to publication in other

THERE SHALL BE NO drilling nor intensive or corrective training of dogs on the show grounds or premises.

NO FLEXI LEADS, HALTI TYPE COLLARS OR PINCH COLLARS ON THE GROUNDS.

NO PRACTICING IN RINGS. DOGS ALLOWED in rings during judging only.

DOGS MUST BE READY FOR JUDGING. The Club and the Superintendent will not be responsible and are not obligated to furnish any service for notifying exhibitors or their agents of breed or class judging. Judges will not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging ring.

DOGS NEED TO BE AT THE SHOW only at scheduled time of judging and may leave immediately thereafter, unless required for further judging.

EXHIBITORS ARE RESPONSIBLE for maintaining clean conditions in and around their crates/set-up.

AKC RULES STATE THAT ONLY DOGS THAT ARE ELIGIBLE to be shown under the American Kennel Club rules shall be allowed within the show precincts.

EXHIBITORS SHOULD FOLLOW THEIR VETERINARIAN'S RECOMMENDATION to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

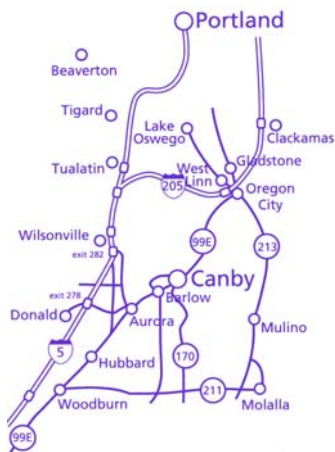
DIRECTIONS TO THE SHOW SITE

4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed.
